Usage of your Be Our Diner membership card constitutes acceptance of the terms and conditions listed below:

1. The Be Our Diner membership card, "the Card", is issued by New World Millennium Hong Kong Hotel, "the Hotel", and entitles Be Our Diner membership card cardholder, "the Cardholders", to certain benefits as deemed appropriate by the Hotel subject to these terms and conditions. Nothing contained in these terms and conditions shall affect the Hotel's right to terminate, alter, amend, vary or limit the granting of any benefits at any time without notice.
2. The Cardholder shall sign the Card immediately upon receipt and shall keep the Card under his/her personal control at all times. The Card is personal to the Cardholder and not transferable. The Cardholder shall not receive any benefits conferred by the Card unless the Card is presented in person by the Cardholder.
3. The Card is not a credit card and confers no right or benefit upon the Cardholders to enjoy services on credit.
4. The Cardholder shall not be entitled to any compensation for any loss incurred whether directly or indirectly resulting from termination of or variations in the granting of benefits by the Hotel. The Cardholders shall be bound by any subsequent alteration, amendment, or variation to these terms and conditions.
5. The Hotel is under no obligation to issue a replacement card to the Cardholder following the damage to or loss or theft of the Card. Any replacement card will be issued at the Hotel's discretion subject to a handling fee as deemed appropriate by the Hotel.

Unless otherwise stated in the membership application form, the Hotel, Rosewood Hotel Group and Millennium & Copthorne Hotel Group may use personal data {as defined in the personal data (privacy) ordinance} supplied by the Cardholder for direct mailing and promotion purposes.
